Supervisor Rieber called the Special Town Board Meeting to order at 6:37 PM for the purpose of conducting the Annual Tentative Special District Assessment Hearing.

## PUBLIC HEARING: TENTATIVE SPECIAL DISTRICT ASSESSMENT HEARING
