Supervisor Rieber called a Moment of Silence regarding the tragic shooting event that occurred Sunday, October 1<sup>st</sup>, 2017 in Las Vegas.

# <u>PUBLIC HEARING: PROPOSED LOCAL LAW NO. 06 OF 2017 – ADDING CHAPTER 118 ENTITLED "DOUBLE UTILITY POLES, REMOVAL OF"</u>

Supervisor Rieber opened the Public Hearing at 7:35 PM.

Deputy Town Clerk, Kelly M. Murran read the legal public notice and stated that she had an original affidavit of publication. Notice of said hearing was duly published in the <u>Sullivan County Democrat</u> on <u>September 26, 2017</u> with same being posted at the Town Hall on <u>September 22, 2017</u>.

Supervisor Rieber explained when NYSEG replaces their lines they attach them to the new poles and leave the old poles in the same location. This law will make it a requirement of the utilities to remove the poles or be subject to a fine. The utilities are also required to put this information into a public service database on the Public Service rules. If a pole is replaced, this information is required to be entered into the public database.

Supervisor Rieber asked if the Board had any comments. The Town Board had no comments.

Supervisor Rieber asked if anyone from the public would like to be heard on this matter:

<u>Pamela Zaichick</u> of Rock Hill asked it this law would require them to remove the old poles that were there prior to this local law? Supervisor Rieber replied that this law would require them to remove all of the old poles as well.

<u>Paul Walsh</u> of Rock Hill said that it was a shame that the Town has to take these steps. Mr. Walsh also asked how much time they would have to remove them? Supervisor Rieber replied that they would have 15 days to comply.

After an opportunity for all persons to be heard Supervisor Rieber entertained a motion that the public hearing be closed.

A motion to close the Public Hearing at 7:40PM was made by Councilman Briggs and seconded by Councilman Sush.

Town of Thompson

Local Law No. 05 of the year 2017

A local law adding Chapter 118 entitled Double Utility Poles, Removal of, in the Town of Thompson Code

Be it enacted by the Town Board of the Town of Thompson, County of Sullivan, State of New York, as follows:

Section 1. New Law Created. Chapter 118 of the Town Code entitled "Double Utility Poles, Removal of" shall be and hereby is created by this Local Law as follows:

# Chapter 101. Double Utility Poles, Removal of

# <u>' 118-1. Findings; legislative intent.</u>

- <u>A.</u> The Town Board hereby finds and determines that public utility companies place poles on Town of Thompson highways, streets, roads, rights-of-way or any other roadway or right-of-way located in the Town to facilitate the delivery of electric, telephone, cable television, and other telecommunications services to the residents of the Town of Thompson.
- <u>B.</u> The Town Board finds and determines that local governments have the authority to regulate their highways, streets, roads and rights-of-way to protect the public.
- <u>C.</u> The Town Board finds and determines that utility poles are damaged from time to time.
- <u>D.</u> The Town Board finds and determines that public safety can be compromised when utility lines and equipment remain affixed to utility poles that are weathered or otherwise damaged.
- E. The Town Board finds and determines that when a new pole is installed, a utility's delay in removing lines and equipment from the old pole also delays the removal of the pole itself, which causes a proliferation of aesthetically unpleasant double poles along highways, streets, roads, and rights-of-way, as well as obstructing the paths of pedestrians.
- <u>F.</u> The Town Board finds and determines that the interest of the public is best served by cooperation and communication between public utilities and the Town Board.<u>G.</u> In enacting this chapter, the Town Board deems this chapter to be an exercise of the police power of the Town of Thompson for the preservation and protection of public safety and is enacted pursuant to the authority contained in the Highway Law, Town Law, and Municipal Home Rule Law of the State of New York.
- <u>H.</u> Therefore, the purpose of this chapter is to require utilities that use Town highways, streets, roads and rights-of-way or any other roadway or right-of-way located in the Town to promptly remove their plants, cables, lines, equipment, and terminals from old and damaged

poles and to further require the prompt removal of double poles once all plants, cables, lines, equipment, and terminals have been removed.

# <u>' 118-2. Definitions.</u>

As used in this chapter, the following terms shall have the meanings indicated:

# **DANGEROUS/DAMAGED POLE**

Any utility pole that is structurally compromised due to weather, a traffic incident, and/or age and poses a potential threat to public safety.

# **DOUBLE POLE**

Any old utility pole which is attached or in close proximity to a new utility pole.

# **PLANT**

The cables, terminals, conductors and other fixtures necessary for transmitting electric, telephone, cable television or other telecommunications service.

# PUBLIC UTILITY

Any corporation, authority, or other entity that provides electric, telephone, cable television, or other service, including telecommunications service, to the residents of the Town of Thompson.

# CODE ENFORCEMENT OFFICER (CEO)

The Town of Thompson Code Enforcement Officer or his/her designee.

# **UTILITY POLE**

A column or post used to support service lines for a public utility.

### WRITTEN NOTIFICATION/WRITTEN NOTICE

A writing directed to a representative of a public utility, who may be designated by the utility to receive such notice, sent by regular mail, facsimile transmission or electronic mail.

<u>'118-3. Notification requirements.</u>No person, firm or corporation subject to the jurisdiction and regulation of the New York State Public Service Commission (PSC) shall place or erect any pole for any purpose on any Town highway, street, road, right-of-way or any other roadway or right-of-way located in the Town, or change the location of any existing pole on any Town highway, street, road, right-of-way or any other roadway or right-of-way located in the Town, without first having provided notification to the Town through the PSC required accepted electronic notification system being utilized by said utilities.

# ' 118-4. Department notification; time frame for removal.

- A. When the Code Enforcement Officer (CEO) is properly notified of the pending installation of a utility pole which is directly next to or in close proximity to another utility pole on a Town highway, street, road, or right-of-way, the CEO will provide written notice to the public utility which has the top plant on the double pole that the plant must be removed within 30 days or be subject to penalty. Upon the removal of each plant, the CEO shall provide written notice to the public utility that owns the subsequent plant on the pole that the plant must be removed within 30 days or be subject to penalty. The last utility to remove its plant is responsible for removing the double pole within an additional 30 days. Failure to comply with the requirements of this provision may result in penalties as provided for in <u>'118-6</u> of this chapter.
- <u>B.</u> When the Code Enforcement Officer (CEO) determines that a utility pole on a Town highway, street, road or right-of-way or any other roadway or right-of-way located in the Town is damaged and poses a potential threat to public safety, the CEO shall provide written notice to any public utility with a plant on the damaged pole that it must remove its plant from the pole within 15 days or be subject to a penalty as provided for in ' <u>1</u>18-6 of this chapter. The last utility to remove its plant is responsible for removing the double pole. Failure to comply with the requirements of this provision may result in penalties as provided for in ' <u>1</u>18-6 of this chapter.
- C. When the CEO determines that a double pole is on a Town highway, street, road or right-of-way or any other roadway or right-of-way located in the Town, the CEO will provide written notice to the public utility which has the top plant on the double pole that the plant must be removed within 30 days or be subject to penalty. Upon the removal of each plant, the CEO shall provide written notice to the public utility that owns the subsequent plant on the pole that the plant must be removed within 30 days or be subject to penalty. The last utility to remove its plant is responsible for removing the double pole within an additional 60 days. Failure to comply with the requirements of this provision may result in penalties as provided for in ' 118-6 of this chapter.

# ' 118-5. Extensions authorized; temporary emergency suspension.

A. Notwithstanding any provision of this chapter to the contrary, the CEO may extend the time frame of any written notice provided under this chapter for an additional period not exceeding the original statutory time frame set forth in this chapter. The public utility shall make a request for an extension in writing to the CEO prior to the expiration of the time frame contained in the original written notice, together with the basis for the request. The CEO shall determine whether the request for extension should be granted or denied, and provide a written response to the public utility. In such instances where the request is granted, the CEO shall issue another written notice, which shall then be applicable instead of the previously issued notice.

### ' 118-6. Penalties for offenses.

Any person, firm, corporation or public utility convicted of a violation of the provisions of this Chapter shall be guilty of a violation, for a first conviction, punishable by a fine not

exceeding \$1,000; for a second or subsequent conviction, punishable by a fine not exceeding \$2,000. Every day that the violation continues shall be deemed a separate violation.

- <u>B.</u> Any public utility found guilty of violating this Chapter and that fails to remove its plant from a damaged pole within 15 days of receiving notification from the Town, pursuant to this Chapter, shall be punished by a fine of up to \$250 for each such violation. Each day that the violation continues shall be deemed a separate violation.
- <u>C.</u> Any public utility that fails to remove a double pole within 90 days of receiving notification from the Town, pursuant to this Chapter, shall be punished by a fine of \$1,000 per full calendar month that the violation continues.
- <u>D.</u> If a person, firm or corporation or public utility violates the provisions of this chapter, the Town Attorney may commence an action in the name of the Town of Thompson in a court of competent jurisdiction seeking any remedy provided by law or equity, including any civil and/or injunction proceeding necessary to enforce compliance and/or enjoin noncompliance with this chapter. Such action may seek to remove damaged poles and/or double poles, or to remove plants from such poles, the imposition of civil penalties as authorized by this chapter, the recovery of costs of the action and such other remedies as may be necessary to prevent or enjoin a dangerous condition from existing on a Town highway, street, road, or right-of-way.

# ' 118-7. Applicability.

- <u>A.</u> This chapter shall apply to all utility poles located on any Town highway, street, road, right-of-way or any other roadway or right-of-way located in the Town, and to all utility poles installed hereafter.
- <u>B.</u> The provisions of this chapter shall be deemed to supplement applicable state and local laws, ordinances, codes and regulations; and nothing in this chapter shall be deemed to abolish, impair, supersede or replace existing remedies of the Town, county or state or existing requirements of any other applicable state or local laws, ordinances, codes or regulations. In case of conflict between any provision of this chapter and any applicable state or local law, ordinance, code or regulation, the more restrictive or stringent provision or requirement shall prevail.

# Section 2. Separability

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Town Board of the Town of Thompson hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

# Section 3. Repeal

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

# Section 4. Effective Date

This Local Law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

# 2.OFFER OF DEDICATION OF ROADWAY – FULOP SUB-DIVISION- FRASER ROAD

Supervisor Rieber stated that this is a 3-4 acre parcel on Fraser Road and Old Liberty Road. The Planning Board requires the developer make an offer to dedicate the edge of the property to the center of the road to the Town. The Planning Board is requesting that the Town Board acknowledge that they want this right-of-way or do not want this right-of-way. Highway Superintendent Benjamin stated that the Town almost always rejects these offers because the road is by use. The Town would have one lot that is a deeded right-of-way which is worthless. There could be time when the Town wants this but the Town does not need it at this time.

# 3.DASNY GRANT – DILLON FARMS WATER DISTRICT IMPROVEMENTS – PRELIMINARY APPLICATION

Supervisor Rieber said the the Town has been approved for a State and Municipal Facilities Capital Program Grant in the amount of \$100,000 to be used for the Dillon Farms Water District Improvements. There are a lot of mandated improvements by the Health Department which were initially estimated at about \$185,000. It is a small district that can ill afford to pay much more than they are paying now. Superintendent Messenger said there were high levels of copper in the water. The building is very small and they need a new pressure tank.

# **4.HEALTH INSURANCE BUYOUT INCENTIVE**

Supervisor Rieber said the Town Code says that an employee has to notify the Town by December that they are eligible for a buyout because they have sufficient coverage elsewhere. In past years, the Town's health insurance provider, NYSHIP, did not allow buyouts. This rule changed as of 06/09/2016 and the Town was not advised of this change until recently. Deputy Administrator Chester was entitled to have this insurance buyout upon her hire in October 2016 but was denied because the Town was not made aware that this law changed.

# **5.TOWN PARK PAVILION STATUS;**

Park Manager Somers believes that it would be best to take the pavilion down and put up another one in the same location or perhaps another location. He received one quote for the removal and will be obtaining two more quotes. Councilman Pavese said that the first step would be just to remove the pavilion and address the possibility of a new pavilion later. Park Manager Somers will report on the RFP's next meeting. The County has agreed to allow the Town to use the remaining 8.8 tons from the spring cleanup on this project.

### 6.DOG KENNELS:

Park Manager Somers reported that he sent for three quotations and received two back. One quote was from Grey's Woodworks in the amount of \$24,500 and the second was from American Storage Buildings, Inc. in the amount of \$17,297. These quotes are for a 12X24 4-kennel unit with insulation, chain link fence, and guillotine doors. The Town would have to get heat and water to the building. The slab is poured and ready to go. Park Manager Somers recommends the Town accept the quote from American Storage Buildings, Inc. in the amount of \$17,297.00. It takes 4-6 weeks from the time the order is placed to receive delivery. Dog Control Officer Nancy Marinchak is very pleased with this unit.
