A majority of such designees must reside in the Town of Thompson or Town of Fallsburg.

Pursuant to Article 2 of the New York State Village Law, we respectfully submit the attached petition to the Town Supervisor of the Town of Thompson for the incorporation of the Village of Ateres. This petition is made by at least twenty percent of the residents of such territory qualified to vote for town officers in the Towns of Thompson and Fallsburg. Exhibits to the petition include:

- A metes and bounds description of the Proposed Village of Ateres;
- A map of the Proposed Village of Ateres;
- A list of the regular inhabitants residing within the territory of the proposed village; and

PETITION FOR THE INCORPORATION OF
THE VILLAGE OF ATERES

We, the undersigned petitioners ("Petitioners"), respectfully state as follows:

1. We hereby submit this petition (the "Petition") to the Town Supervisor of the Town of Thompson and to the Town Supervisor of the Town of Fallsburg pursuant to Article Two of the New York State Village Law (the "Village Law") to commence the proceedings to incorporate as a village certain territory (the "Incorporation Territory") located within the Town of Thompson and the Town of Fallsburg.

2. There are 308 residents of the Incorporation Territory who are qualified to vote for town officers in the Town of Thompson. There are 14 residents of the Incorporation Territory who are qualified to vote for town officers in the Town of Fallsburg. There are, thus, a total of 322 residents of the Incorporation Territory who are qualified to vote for town officers in the Towns of Thompson and Fallsburg.

3. Because 94 Petitioners from the Incorporation Territory within the Town of Thompson have signed this Petition, and because 5 Petitioners from the Incorporation Territory within the Town of Fallsburg have signed this Petition, this Petition is signed on the basis that the Petitioners constitute at least twenty percent (20%) of the residents of the Incorporation Territory who are qualified to vote for town officers in the Towns.

4. The name of the proposed village is the Village of Ateres.

5. The Incorporation Territory contains a population of at least five hundred regular inhabitants.

6. The Incorporation Territory satisfies the area requirements of New York Village Law §2-200 because the Incorporation Territory does not include territory that is part of a city or village and does not contain more than five square miles.

7. Any papers required to be served in connection with the proceedings for incorporation shall be served on the following persons at the following addresses, a majority of whom reside within the Incorporation Territory:

8. Attached as **Exhibit A** and securely fastened hereto and located prior to the Petition's signature pages, is a description of the Incorporation Territory sufficient to identify the location and extent of such territory with common certainty and which is in the format of a metes and bounds description (the "Metes and Bounds Description"). The Metes and Bounds Description is the description of the Incorporation Territory boundaries prepared in accordance with Village Law § 2-202(1)(c)(1).

9. Attached as **Exhibit B** and securely fastened hereto and located prior to the signature pages, is the Village of Ateres Map ("Village Map") which visually depicts the Incorporation Territory for purposes of convenient reference.

10. The Metes and Bounds Description is the official legal description of the Village of Ateres and in the event of any inconsistency between the Metes and Bounds Description and the Village Map, the Metes and Bounds Description shall govern.

11. Attached as **Exhibit C**, securely fastened hereto and located prior to the signature pages, is the list of the names and addresses of the regular inhabitants of the Incorporation Territory (the "Regular Inhabitants List"), which was prepared in accordance with Village Law § 2-202(1)(c)(2). The Regular Inhabitants List includes the names and addresses of "all persons residing in the territory proposed to be incorporated except such persons who themselves, or who are persons under the age of eighteen years residing with persons who, maintain a residence outside such territory which is used as their address for purposes of voting." Village Law § 2-200 (2).

12. As confirmed in Exhibit C, the Incorporation Territory has 834 regular inhabitants, in excess of the five hundred (500) regular inhabitants required by Village Law § 2-202(1)(b)(3).

WHEREFORE, the Petitioners who have signed the signature pages appended hereto hereby petition the Town Supervisor of the Town of Thompson and the Town Supervisor of the Town of Fallsburg to commence the proceedings to incorporate the Village of Ateres as provided in the Village Law.
