RESOLUTION REAFFIRMING NEGATIVE DECLARATION UNDER SEQR FOR THE CONSOLIDATED KIAMESHA LAKE SEWER DISTRICT WASTEWATER TREATMENT PLANT UPGRADE PROJECT WITH CWSRF FINANCING

WHEREAS, the Town Board of the Town of Thompson declared itself lead agency pursuant to Resolution dated May 19, 2020 in connection with the review of the proposed Kiamesha Lake Sewer District Wastewater Treatment Plant Upgrade Project with CWSRF financing; and

WHEREAS, the Town Board of the Town of Thompson, by Resolution dated June 15, 2021 approved the consolidation of the Anawana Lake Sewer District, Kiamesha Lake Sewer District, Harris Woods Sewer District and Lakeview Estates Sewer District into the Consolidated Kiamesha Lake Sewer District, effective January 1, 2022; and

WHEREAS, a Full Environmental Assessment Form was filed in connection with the proposed Project; and

Town Board Meeting May 20, 2025 Page 2 of 11 WHEREAS, the Town Board of the Town of Thompson determined that there would be no negative environmental impacts that would be caused as a result of the Consolidated Kiamesha Lake Sewer District Wastewater Treatment Plant Upgrade Project and a negative declaration was issued on July 07, 2020; and

WHEREAS, during the design process soil borings indicated that the soil conditions at the original location of a proposed sludge digester would not be suitable for supporting the structure, so an alternative location was chosen; and

WHEREAS, relocating the sludge digester from the original location in the southeast portion of the parcel to a previously disturbed area on the north side of the same parcel will not result in any adverse environmental impacts; and

WHEREAS, on January 16, 2024, the Town Board of the Town of Thompson reaffirmed the negative declaration originally issued on July 07, 2020 with regards to any and all environmental impacts associated with the aforesaid Treatment Plant Upgrade; and

WHEREAS, upon completing the design for the Treatment Plant Upgrade it was determined that the area of disturbed land changed from less than one acre to approximately 2.3 acres, requiring a SWPPP to be prepared; and

WHEREAS, the Town Board of the Town of Thompson has had an amended Full Environmental Assessment Form prepared, dated May 19, 2025, which acknowledged the aforesaid change in disturbance area, and, same further indicates that change does not result in any adverse environmental impacts.

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Thompson, as follows:

The Town of Thompson has received your request regarding the above-captioned matter. In order to extend the Consolidated Harris Sewer District for parcel 29-1-21, several steps will be necessary, including having a Map, Plan and Report prepared to determine the costs and feasibility of same, as well as submitting a request to the Village of Monticello to gain approval of the extension to allow the usage of additional services to treat the additional flow from this extension.

In order to proceed with ordering the Town Engineer to prepare a map, plan and report, it will be necessary for you to place \$11,000.00 in escrow to pay for district expenses that will be incurred during the process.

The estimated cost for preparation of map, plan and report is \$5,000.00; legal fees for preparation of the extension documents for the board will be \$5,000.00, and incidental costs for the numerous publication of hearing notices, filing fees with the county, and service fees with the New York State Comptroller's Office are approximately \$1,000.00. Accordingly, the Town will require \$11,000.00 to be placed in escrow with the Town Comptroller.

A. INTRODUCTION

Catskill Veterinary Services, LLP is proposing the construction of a new facility in the Town of Thompson near the intersection of Glen Wild Road (County Route 58) and Rock Hill Drive (Town Road 52). To address sanitary sewer needs related to the proposed development, Joseph D'Abbraccio, Managing Partner, petitioned the Town of Thompson Town Board through correspondence dated December 11, 2024 for the extension of the Consolidated Rock Hill – Emerald Green Sewer District. The Town Board, therefore, authorized MHE Engineering, D.P.C. on January 21, 2025 to prepare the following Map, Plan and Report for the Sewer District Formation. The correspondence and authorization are provided as Attachment No.1 to this report.

B. <u>BENEFIT AREA</u>

The District extension will include tax map parcel 32.-1-14.1 which consists of approximately 16.52 acres. The parcel address is 230 Old Drive In Road, Rock Hill, New York 12775. The parcel is located within the Town's HC-1 and HC-2 zoning districts.

The District boundary is more formerly shown on Attachment No. 2 and described in Attachment No. 3.

C. <u>BACKGROUND</u>

The Consolidated Rock-Hill-Emerald Green Sewer district provides services to the general Emerald Green residential community area and the Rock Hill business area. Wastewater flows are collected in a system of gravity sewer mains for conveyance to the wastewater treatment plant located on Lake Louise Marie Road. There are also 11 pump stations within the system. The location of the wastewater treatment plant and pump stations are shown on the District Plan in Attachment No. 2. The district contains approximately 1,500 properties of which approximately 60% are residential and 40% commercial.

The existing WWTP has a design capacity of 410,000 gallons per day. As the WWTP is

approximately 35 years old, upgrades and an expansion of the WWTP capacity to 475,000 gallons are currently being undertaken by the Town.

D. <u>PROPOSED DEVELOPMENT</u>

Catskill Veterinary Services, LLP is proposing the construction of a new veterinary hospital and medical facility on parcel 32.-1-14.1. The project consists of a 16,185 square foot building which will consist of veterinary offices, exam rooms, pharmacy and support services. The facility will have approximately 55 employees. Parking, stormwater facilities and access driveways will also be constructed on the site. Potable water will be provided by on-site private wells. The facility is expected to generate approximately 8,832 gallons of wastewater per day at full capacity. The development of this parcel will allow Catskill Veterinary Services to relocate from their current location on Rock Hill Drive, which is also currently within the sewer district. Sewer flows at the WWTP are, therefore, not expected to increase substantially.

E. <u>PROPOSED IMPROVEMENTS</u>

The property is located to the north of Rock Hill Drive. An existing 8" diameter gravity sewer main is located within Rock Hill Drive. The existing main terminates at a manhole approximately 200 feet east of the site access from Rock Hill Drive. The distance of the proposed facility from the existing sewer main and elevation change require that an on-lot pump station be constructed to convey wastewater flows from the site to this manhole.

The project engineer has designed the on-lot pump station and a 2" diameter PVC force main to serve the project. The pump station will have two 3/4 hp grinder pumps each capable of discharging 23 gallons per minute at a head of 27 feet to accommodate peak flow rates from the project. The force main will be approximately 875 feet in length. These improvements will only serve the project site.

Flows generated by the project will be discharged to the gravity collection system which flows east along Rock Hill Drive to the Rock Hill Pump station. This pump station already receives flows

from the current Catskill Veterinary Hospital site. Therefore, any increase in flows to the collection system and pump station will not be significant.

F. <u>REGULATORY APPROVALS</u>

The proposed project will generate in excess of 2,500 gpd of sewage. The project meets the definition of a sewer extension per 6 NYCRR Part 750 1.2(83) and, therefore, will require approval by the NYS DEC. A permit for connection to the existing collection system will be required from the Town Sewer Department and a road opening permit will need to be obtained from the Town Highway Department.

G. <u>PROJECT COSTS</u>

The onsite collection system, pump station and force main will be constructed and paid for by the project developer. As noted above, additional improvements and costs to the District are not anticipated.

H. OWNERSHIP AND OPERATIONS

Upon completion of construction, the onsite collection system, pump station and force main to the point of connection with the District gravity collection system will be owned and operated by the property owner. The District will continue to operate the existing District collection system and treatment plant.

I. <u>ANNUAL COSTS</u>

The Town of Thompson currently assesses annual debt costs and operation and maintenance (O&M) costs on a point system, which is based upon property use classification. The current schedule of points for the District is provided in Attachment 4.

The annual sewer fee for a parcel in the District Extension will be calculated by multiplying the sewer points for the property classification by the cost per point. Parcels are assigned Rent points which are for operations and maintenance (O&M) of the system and Debt points which

are assessed for payment of debt associated with capital construction of the system.

The Town Board passes Local Laws which establish the fee charged per point for Rent and Debt for each sewer district. The Board most recently passed Local Law 04 of 2024 which established these rates for the Rock Hill/Emerald Green Consolidated Sewer District. A copy of Local Law 04 of 2024 is provided in Attachment 5. The current rate for the District is \$60.45 per Rent point and \$14.67 per Debt point.

The current parcel has property classification 331, which is vacant commercial. The schedule of points indicates that vacant commercial parcels are assessed 0 Rent points and 4 Debt points. If the parcel to be annexed into the District remains vacant, the sewer fees assessed would be:

4 Debt points (\$14.67/point) = \$58.68 per year

If the property is developed into a veterinary clinic, it is anticipated that the New York State Classification Property Code would be 642 – Small Health Care Office. This is the same classification as the current Veterinary Clinic use in Rock Hill is assessed. The Town of Thompson Schedule of Sewer points assesses property classification 642 at 20 Rent points and 20 Debt points plus 8 points per 1,000 square feet. Sewer fees charged to the developed parcel would then be calculated as follows.:

Proposed building is 16,815 square feet /1,000 square feet (8pts/1,000) = 134.5 pts Total points = 134.5 + 20 + 154.5 points for O&M and Debt

> O&M (Rent) 154.5 Points (\$60.45/Point) = \$9,347.25 Capital Debt 154.5 Points (\$14.67/Point) = \$2,266.52 Total Annual Cost = \$11,613.77

A single family home within the district will continue to be assessed 10 O&M points:

O&M (Rent) 10 points (\$60.45/point) = \$604.50 Annual O&M Costs

J. <u>CONCLUSIONS</u>

The costs associated with the annexation of the Catskill Veterinary property and project into the Consolidated Rock Hill/Emerald Green District and the costs assessed to the proposed project have been identified above. The District will not issue or assume any debt for the extension and O&M costs will not change.

Dear Secretary Phillips:

On July 7, 2023, Crystal Water Supply Company, Inc., ("Crystal Water") petitioned the New York State Public Service Commission for an order from the New York Public Service Commission (the "Commission"), pursuant to Section 89-h of the New York Public Service Law ("PSL"), for an order approving the acquisition by Kiamesha Plumbing, Inc. of 100% of Crystal Water's issued and outstanding capital stock under case 23-W-0377.

Due to the lack of complete responses to a number of Staff of the Department of Public Service Interrogatory/Document Requests by the current operator of Crystal Water's water system ("System") and opposition of the transfer by certain customers and the Hidden Ridge Homeowners Association, Inc., a decision regarding the petition has been delayed.

Crystal Water is owned equally by Mark Kutsher, Elaine Mady Prowler, and Karen Wilson ("Owners"). The Owners of Crystal Water are unable to continue operation of the System and to meet the requirement of oversight and water quality monitoring of the System. Ms. Prowler and Ms. Wilson live out of state and are not interested in operating Crystal Water. Mr. Kutsher's health has been deteriorating for a number of years, so the day-to-day operations of Water was turned over to Allan Schachnovsky. As noted above, Mr. Schachnovsky's ability to operate Crystal Water has been called into question by certain customers and the Hidden Ridge Homeowners Association, Inc. Due to the customer/HOA complaints and the lack of an alternative to operate Crystal Water it is imperative that a new operator be approved immediately.

The Town of Thompson ("Town") is willing to serve as temporary operator of the System pending the formation of a water district in the Town and subsequent acquisition of the assets of Crystal Water, so the customers of Crystal Water will not be without water service.

The Town hereby petitions the Commission to be appointed as temporary operator of the System. The Town operates other community water systems, and has the technical, managerial, and financial capability to properly operate the System in conformance with the requirements of the New York State Department of Health.

In connection with the Town taking over the System, the town is requesting that the quarterly surcharge be increased to \$50.00 to help fund necessary repairs and upgrades to the system. The needed repairs and upgrades include, but are not limited to, **[ADD LANGUAGE-**

add some known or at least expected repairs or improvements, and where possible estimates of the associated costs. If a brief appendix pointing to that would be more efficient, that's fine too]

By approving this request, Crystal Water's customers will receive safe and adequate water service that will meet the requirements of the New York State Department of Health, pending the formation of a Town Water District to serve Crystal Water's customers on a permanent basis.
